- 1. Mayor Marburger to call meeting to order at 6:00 p.m.
- 2. Consideration and possible action to approve a Donation Letter from Alegacy Development for the design of water and sewer utilities.

City Secretary Jo Ann London explained that the donation letter from Alegacy is to give the city funds to design the water and sewer line extension to the property which they own and is currently outside the city limits. She stated that Council had agreed to run utilities to the property once it is in the city's ETJ and that the City of Houston was in the process of releasing to Waller. The Alegacy Group wanted to proceed with the design of the facility, knowing two conditions: 1) if the ETJ was not released to Waller then Alegacy would not be refunded the funds spent on the design and 2) if the ETJ was released to Waller then these funds would be used as a credit to the portion of the utilities Alegacy would pay for during construction of the project. Supt. of Public Works Gene Schmidt stated that David Leyendecker, engineer for the city, could start work as soon as we gave him the okay and that he saw no issues with the funds for the design. After a brief discussion, Councilmember Arnold moved to approve the donation letter from Alegacy Development for the design of the water and sewer utilities. Councilmember Johnson seconded the motion and it carried unanimously.
